RELEASE FROM LIABILITY AND INDEMNIFICATION

I recognize that the event can be dangerous to me (or my child) and accept those dangers. I understand that if I am (or my child is) injured, this waiver will be used against me and anyone else claiming damage because of my (or my child's) injury in any legal action. I also understand that no employee or agent is authorized to modify this waiver.
